**1. Appeal regarding the sanctions – decision (169) – request for GM decision**

The WRRC Presidium received an appeal to the decided sanctions from the following individuals:

- Luca Bihari
- Alex Deli
- Adam Kiraly
- Greta Mercs

After thorough discussion, the Presidium concluded that the appropriate course of action (following WRRC Statutes Paragraph §18 point 3) is to convene an Extraordinary General Meeting. This meeting will address and resolve the complete situation.

**(182) The WRCC Presidium decided to convene an Extraordinary General meeting following the WRRC Statutes - Paragraph §11 point 1 based on the appeals received by Luca Bihari, Alex Deli, Adam Kiraly and Greta Mercs.**

**(183) The Extraordinary General Meeting (EGM) will take part on Tuesday August 6, 2024 starting at 16:00 CET. The EGM will be organized online in order to enable all delegates to attend the meeting on such short notice. The EGM will only address the points of urgency. The President will convene the EGM as written in the Statutes.**

**The preliminary Agenda for the meeting will include the following points**

- Appeals regarding the Presidium decision 169 – sanctions
- Confirmation of the change of VP for marketing and expansion – Lena Arvidsson
- Election of the chair of Arbitration committee

**(184) Additional to the delegates, the persons who have appealed to the WRRC Presidium can be present as well. Greta Mercs, who is a minor, can be represented by her parent or other legal guardian.**

**2. Appeal regarding the sanctions – decision (169) – request for reduced suspension**

The WRRC Presidium received an appeal letter from Bence Toth with a request to cancel or at least reduce the suspension period.

In view of the defense arguments that have been sent to the Presidium no argument provided justifies the removal or even the reduction of the suspension that has been decided.

**(185) The appeal from Bence Toth was rejected. He will be informed in writing about the decision and possible further actions.**

### **3. Inquiry letter from the Hungarian DanceSport Federation**

**(186) The WRRRC VP for Legal affairs and WRRRC President will answer Hungary.**

### **4. Finance**

The Vice President for Finance informed the Presidium that the tournament fees and starting fees from competitions held in Zabrze and Cork have not been paid to date. Since starting fees are paid directly by the dancers, there is no valid reason for the organizers to delay the payment. Failure to pay these fees on time means that the WRRRC cannot distribute the money to the dancers as intended.

**(187) The Presidium calls all organizers to pay their Invoices on due date.**
