The President opened the meeting on March 13, 2026, at 14:00

1. Minutes from the last Presidium Meeting

Online Presidium meeting February 12, 2026. (09:00 – 10:30)

The meeting related to the upcoming General meeting, financial situation and urgent topics.

The Presidium confirmed the workshops, the flow of the weekend and individual tasks of each Presidium member.

The Presidium also confirmed the setup of GM material and inclusion of candidates for new Presidium in general information file.

(283) Finances:

- **To receive the subsidy money each county must send a report regarding the usage of the funds received**
- **The Presidium decided to present the unpaid competition fee from Ireland as a financial loss**

The Presidium also discussed about the motions for GM and clarified the text for the Presidium motions.

Denis Lilih reported about two successful WRRC judging seminars – Boogie Woogie – live in Munich and Rock'n'Roll online.

Leo Beck and Denis Lilih reported that latest versions of all rules were published online.

2. GM 2026

The Presidium discussed the logistic and administration for the GM.

Jiri Hais and his team have prepared all the materials, badges and country/name signs.

Clarification of some points:

- Jiri Hais and Bartłomiej Kobylanski are responsible for the MentiMeter setup

- Additions to the Agenda must be confirmed by 2/3 majority
- If a candidate for the Presidium doesn't get enough votes (more YES than NO) the Presidium can appoint a person to the open positions until the next GM.

The Presidium discussed also about the presentations planned for the workshop on Saturday and decided to confirm the proposed ranking of contribution of national members to WRRC

- (284) The Presidium approved the proposed ranking of contribution of national members to WRRC. The top 3 countries shall get a special awarded during the GM**

3. Competitions

Denis Lilih and Marina Eskolin presented the conditions for the long-term contract with GOC – next 4 years.

- (285) The Presidium approved the conditions of the contract with GOC for the period 2026 - 2030.**

- (286) The Presidium confirmed Mirjam Kerpan Izak as potential Supervisor for the events in 2026.**

The Presidium discussed about the option to implement a special group of Supervisors with education and licensing system to enable better control on the WRRC events. The new Presidium shall discuss about this option.

4. Honoration

Marina Eskolin proposed to award a title of Honorary President to the outgoing WRRC President Mirjam Kerpan Izak

- (287) The Presidium awarded the title “Honorary WRRC President” to Mirjam Kerpan Izak.**

5. WRRC Office

Mirjam Kerpan Izak, Marina Eskolin and Denis Lilih have prepared the tasks for WRRC Office. After a discussion and proposal from Bartek, the following was accepted

- (288) The Presidium decided to present the tasks of WRRC Office on the forum and invite national members to send the potential candidates.**

6. Boogie Woogie

Boogie Woogie commissioner Ayna Nygaard joint the Presidium and presented the work of the commission and future plans.

Some important topics were discussed:

- How to empower the raising star category
- How to find organizers for Boogie Woogie events
- The commission view on the motions
- Challenges with expansion in Europe and Worldwide

Further plans and tasks will be communicated by the new WRRC Presidium.

7. Any other item

Miriam Kerpan Izak pointed out that the transfer of authority and connected tasks must be carried out after the election of a new President.
