The President opened the meeting on March 15, 2026, at 15:30.

1. Welcome of the new president

ME welcomed all new and re-elected presidium members and swore everyone in for good, constructive and successful cooperation

2. Future Presidium Meetings

ME presented her idea that future meetings should take place once a month in the morning. It was agreed to hold the first meeting on **April 14th 2026 from 9.00 to 12.00**. DL will invite by zoom.

3. Mail addresses

- DL will instruct our IT provider to set up email addresses for the new presidium members
- A new email address will be set up for Miriam Kerpan-Izak in her role as honorary president (DL)

4. Vice President Communication

After a brief discussion Senad Softić was unanimously nominated and elected by Presidium till the next GM as successor for the vacant VP Communication position. Senad Softić agreed.

5. Statutes Commission

A statutes commission will be appointed to revise and adapt the statutes accordingly. Members will be LB, Miriam Kerpan Izak and Borbala Patona.

6. WDSF General Meeting in June, Rome

PdIT will accompany ME, together with Senad Softić (SS).

7. Finance

- ME and DL will handle access to financial matters for OG
- Due to the objections raised by the auditors the VP Finance will in future only accept digitally completed claims.

8. Communication

The contract with Rasto Banas will end at the end of march 2026. Senad Softić will handle the social media matters as soon as possible.

The official Facebook, Instagram, and TikTok pages need to be updated accordingly.

9. WRRRC Office

At the AGM a call was made by the former president Miriam Kerpan Izak to find suitable persons to fill the vacant position in the WRRRC Office.

In the meanwhile, ME found a person who could take on the task. The person agreed to do the work on a test period. Provided the cooperation proves successful, further steps will be taken towards concluding a contract.

10. Tasks

- DL will send a reminder letter to the member federations to remind them about the registration of dancers and coaches.
- WRRRC Merchandise activities will be overtaken by Senad Softić
- The options regarding web shop activities are being reviewed. The web shop will initially be managed by Bartłomiej Kobylanski until the end of 2026.
- Due to the presidiums decision to extend the contract with the GOC for five years and the conditions agreed therein, it is necessary to take care of procuring trophies and medals. OG will take care of this.
- DL will send out the call to national federations to nominate the organizer of next GM for 2027.

The next Presidium meeting is planned on April 14th online 9.00 to 12.00.
